Message from the Communications Chair



February is Low Vision Awareness
Month. The National Eye Institute defines
low vision as "visual impairment that cannot
be corrected by standard eyeglasses, contact
lenses, medication or surgery." I view low
vision as any vision loss that limits my patient's ability to live their lives to their fullest
potential.

As the primary eye care provider, we are the gatekeepers to our patients' vision and ocular health needs. We should provide them with the best options for maximizing their visual potential. However, with low vision patients, this may prove more difficult. It will likely expand beyond the scope of glasses and contact lenses. It is important to ask them about their activities of daily living — and how these may be inhibited. Get to know their support structure: do they live alone,

are there family or friends that help them, do they qualify for services.

As optometrists, we are typically the providers that have to tell the patient, "Nothing more can be done for your vision." This statement can be psychologically debilitating, causing depression, inactivity, loss of independence, and an overall decline in the patient's health. I believe strongly in advocating for my patients, searching for an interdisciplinary answer to my patient's health care needs.

This may include a low vision exam, referral to a rehabilitation center such as the Valley Center for the Blind, sending a letter stating legal blindness, filling out paperwork for a DMV handicap placard or Handy Ride. I will oftentimes be seen changing the accessibility features of my patient's smart phones to increase the contrast and font size. These are the many small, but significant, changes that we can bring to our patient's lives.

the President's Message

On February 10 and 11, House of Delegates assembled in San Diego, a city commonly known as "America's Finest City." There were 159 delegates representing 25 optometric societies from across the state. This year's annual event was held at the beautiful Marriott Hotel Mission Valley.

Traditionally the event begins with the "Parade of Society Presidents".

Sadly CCOS did not have a society flag, but I used the CCOS table placeholder to remind us that one day CCOS will march with the Society Presidents.



Another time-honored tradition at HOD is to hear Dr. Saul Levine's rich, baritone voice singing to the delegates. However, I was disappointed when I didn't hear Saul's special musical number at the beginning of the event.





Later in the program Senator Ed Hernandez, OD, was given time at the podium. He walked us down memory lane and reminded doctors that when he graduated from optometry school, he could only use fluress and tropicamide! He was frustrated that despite his extensive training, California law prohibited optometrists from doing more. Senator Hernandez decided to get involved and make changes at the political level. He also emphasized the importance of having mentors and optometric support as he endeavored to enter the political arena. He still needs our support for his next political race to be Lieutenant Governor! You may contribute to his campaign by visiting edhernandez4ca.com.



Towards the end of his speech, Sen. Hernandez asked Dr. Levine to come up on stage for a special song. Dr. Levine composed a song dedicated to Dr. Ed's campaign for Lt. Governor. Check out the video on www.ccosociety.org.





The 2018 delegates proudly representing CCOS are Michael Mendoza (President-Elect), Margie Recalde (President), Andrew Ta (Membership Chair) and Chris Fisher (Member-At-Large).

Here are several key points from the HOD meeting:

 Branch Office Law – This was a highly controversial topic. The branch office law limits optometrists to no more than two offices. The California State Board of Optometry is planning to eliminate the branch office law.

Delegates heard pros and cons from both sides of the table. MDs and opticians may have multiple offices but a group OD practice is limited by the Branch Office Law. The original goal of the law was to protect patients and ensure that patients may have direct access to the owner. At the end of the debate, most of the doctors expressed interest to keep the Branch Office Law but adjust the language to make it more flexible for group OD owners to practice in more than two offices.

- 2) Public Vision League (PVL) The purpose of PVL is to enable COA to aggressively and proactively advocate for the optometric profession in legal matters. PVL has taken the following steps to prevent companies from issuing prescriptions based primarily on autorefraction:
 - A) Filed complaints against Opternative, Simple Contacts, Hubble Contacts, JCPenny Optical, Jins Optical, 2020 Now, Smart Vision Labs and Devlyn Optical with the appropriate state agency.
 - B) AOA has filed complaints with the Fair Trade Commission and the Food and Drug Administration
 - C) Collected examples of harm
 - D) Testified at State Board of Optometry (SBO) hearings to encourage the SBO to take action against online refraction

NOTE: You can help PVL succeed in this legal battle. If you have a patient between 18 and 40 who came to you asymptomatic, but had a life- or sight-threatening condition that you were able to detect during your exam, please report the case to COA.

3) PVL and Corporate Practice Optometry

The California State Board of Optometry (SBO) has completed its investigation of PVL's complaint and sent 17 citations to Stanton Optical for violations of the California Business and Professions Code and California Code of Regulations. SBO has ordered Stanton to pay the maximum allowed administrative fine (\$5,000) for each citation. Stanton Optical has appealed this decision.

4) PVL and Disruptive Technologies

PVL will work with COA's Legislation and Regulation Committee to press regulators including the State Board of Optometry and the Medical Board to enforce the law and prevent online refraction from being available in California. PVL will also advocate that regulators enforce the law against so called "telehealth" services that allow office technicians to perform subjective refraction illegally.

5) PVL and Opticians Scope Expansion

The optician on the California State Board of Optometry has expressed interest in discussing the scope of practice for opticians at a future board meeting. If that occurs, PVL and COA's Legislation and Regulation Committee will provide optometry's perspective.

6) Corporate Practice Concerns

COA is investigating concerns about medical groups interference in the professional judgment of an optometrist. Please contact Kristine Shultz at kshultz@coavision.org or (916) 622-5027 if you work in a corporate setting and there has been an attempt to coerce you into to selling more products or any pressure to reduce the time spent with your patients.

7) Medi-Cal & COA

COA will be advocating for an increase in reimbursement rates for doctors of optometry under the Medi-Cal system. Provider rates in California are among the lowest in the nation and need to be increased to ensure doctors can continue to accept Medi-Cal patients.

8) 2017 COA Membership Review

- While membership numbers are flat for 2017, for the first time since 2014 dues revenue is up.
- COA is seeing more and more students being retained through the ascending dues scale.
- There are 78 percent more members on the third and fourth year levels at the conclusion of 2017 than there were in 2015 (91 vs. 51). More members being converted and retained through the ascending dues scale will ultimately mean more full dues-paying members.
